**Explanation of Responses:**

- Kleiner Perkins Caufield & Byers XIII, LLC ("KPCB XIII") made pro rata distributions for no consideration of 699,450 shares of common stock of the issuer to its members on February 21, 2013.
- The shares are directly held by KPCB XIII. The managing member of KPCB XIII is KPCB XIII Associates, LLC ("KPCB XIII Associates"), of which the Reporting Person is a member. The voting and dispositive control over these shares is shared by certain members of KPCB XIII Associates, none of whom, including the Reporting Person, has veto power. Excludes 360,454 shares in the aggregate beneficially owned by individuals and entities associated with KPCB XIII and held for convenience in the name of "KPCB Holdings, Inc. as nominee," for the accounts of such individuals and entities each of whom exercise their own voting and dispositive control over such shares.
